

Interfraternity Council Philanthropy & Service Fund

In order to promote the pillar of service within the Interfraternity Council (IFC), the IFC programming division has established the Interfraternity Council Philanthropy & Service Fund. The purpose of the fund is to supplement fraternities in their philanthropic endeavors. Chapters are encouraged to collaborate with other IFC chapters and non-IFC organizations in order to receive maximum funds.

Please complete the following form and review the rules and restrictions of the IFC Philanthropy & Service Fund before submitting the application to the IFC Vice President of Programming box in 102 Sproul Hall. Your application will be reviewed and you should expect a response within two weeks. Applications are accepted on a rolling basis.

Rules and Information

- 1) The IFC Vice President of Programming reserves the right to discretion in allocating funds to philanthropy events.
- 2) The fund acts as a means of reimbursement. The event must be held and receipts must be given to the IFC Vice President of programming within a week of the event or the funding is void.
- 3) Applications must be submitted within a week of the event.
- 4) The Interfraternity Council Philanthropy & Service Fund has a total of \$1000 to be distributed among IFC chapters.
- 5) The IFC Philanthropy & Service Fund application shall be limited to IFC chapters in good standing with IFC.
- 6) Applications will be reviewed by the IFC VP of Programming and IFC Assistant Programming Officer. Eligible applications will then be voted on by IFC Executive members (VPs and the President), as well as by the assistant VP of Programming. 5/7 approvals are needed to receive funding.
- 7) Applications will be judged on:
 - Organization of event finances and operations
 - Philanthropy that will receive funds
 - The event's accessibility to other students
 - Earnings potential for philanthropy or level of service to the community
 - Collaboration with other CalGreek organizations
 - Collaboration with other IFC Chapters
- 8) Reimbursement agreements will not be honored unless a Service Tracking Form has been completed.
- 9) Reimbursement agreements will not be honored unless a short summary (100 word minimum) of the event including, but not limited to, its earnings, turnout, impact (monetary or otherwise) and appropriate media (pictures, videos) are submitted to the IFC VP of Programming. This write up is subject to use and distribution by any appropriate media including but not limited to newspaper, television, and electronic providers.
- 10) Events must meet all requirements of the All-Greek Social Code

Restrictions

- 1) Funding for each event will not exceed \$100 for a single IFC fraternity.
- 2) Funding for each event will not exceed \$150 for a single IFC fraternity collaborating with a non-IFC chapter.
- 3) Funding for each event will not exceed \$200 for a multiple IFC fraternity event.
- 4) Each Fraternity may only apply to the fund once a semester.
- 5) The fund will not reimburse for:
 - Alcoholic Beverages
 - Bartenders

- Food and drinks
- Any other criteria is up to the discretion of Programming Officers
